Elections and electoral rules in public administration in V4 countries

Self-government as a basic subsystem of public administration represents a decentralization of the state power which is typical for the majority of democratic states, especially in relation to elected bodies of territorial units. The aim of a professional discussion is to find the answers to questions which merge as a consequence of many political intentions at recent time mainly in connection with the change of electoral rules for the election to the bodies of territorial self-government in the Slovak Republic.

Third decade of the public administration systems in V4 countries

Since 1989 the political and social system of the Visegrad group countries has been transformed. Changes have concerned not only political institutions but also public administration and its subsystems. The aim of a professional discussion is to find the answers to the key questions related to present, past and future performance of public administration in the countries within a common geographical area of central Europe.
